Hidden Valley Facilities' monetary transactions guideline.

Hidden Valley chalet and trails are maintained by the Ely Nordic Ski & Bike Club (the club) in order to promote and enable Nordic skiing, mountain biking and other recreational activities at the Hidden Valley Recreation Area (HVRA). The club, as managing agents of HVRA, is tasked with the financial responsibility of collecting necessary funding to offset costs associated with the upkeep of the Hidden Valley facility. In an effort to reduce the overhead costs of maintaining such facility, it has been set forth by prior administration that the chalet be available for rent on an hourly or daily basis.

Rental activity usually is limited to parties and gatherings, but where a rental activity involves the sale of goods or services, special rules apply. These rules apply to any event that occurs at the HVRA that causes a transfer or exchange of funds to occur. These events are characterized as, but not limited to, races, concerts, bake sales, fund raisers, classes, sessions, trainings or personal instructions. Although each monetary exchange transaction will be negotiated on a case-by-case basis a basic guideline to expect is 20% of the net profit of such activity will be donated to the Ely Nordic Ski & Bike Club.

HVRA trails are open for all to enjoy, however, organizations who utilize HVRA as part of their programming for paid participants (such as camps) are expected to offer a reasonable donation to the club to help offset trail maintenance costs.
